The seller agrees to pay **Indee Online Auctions** \$1.00 per lot fee plus the commission rate of:

Items selling for	\$10.00 and under is 20%
Items selling for	\$11.00 to \$499.00 is 10%
Items selling for	\$500.00 to \$999.00 is 5%
Items selling for	\$1000.00 and above is 0%

### **Terms**

- 1.Indee Online Auctions is not responsible for any payment to any seller of any item for which the Indee Online Auctions has not been paid for.**
2. Seller appoints Indee Online Auctions as their agent to conduct a public auction of personal property. Owner authorizes and confers upon Indee Online Auctions the power to take all actions on its behalf necessary to complete this auction.
3. The items of personal property shall be sold at public auction to the highest bidder.
4. All items shall remain in the possession of Indee Online Auction until full payment has been received from the purchaser.
5. The property will be sold in lots determined by the seller or Indee Online Auctions may determine as necessary lots on the seller's behalf.
6. Reserve items will have a \$10.00 fee if they do not sell on the Auction.

### **Agreement of the Owner:**

1. The owner warrants that they are the owner of and that has merchantable title to the items of personal property offered for sale and grants Indee Online Auctions the right to convey a merchantable title to such property to buyers successful bidding at the auction.
- 2.Owner is responsible for all the items while they are in the possession of Indee Online Auctions that being said you the seller cannot and will not hold Indee Online Auctions accountable for lost, stolen, damaged property, the owner of the property must carry the proper insurance to protect their interest in their personal property. ## **How to consign with us**

- 1. You will need this sheet filled out prior to your appointment.**
2. You need green painters' tape and a sharpie or black permanent marker.
3. You need to know your bidder number.
4. Lot up your items that you want to consign there can be 1 item per lot or multiple items per lot if there are multiple items per lot you should put them in a pop flat or box.
5. Now take the green painters tape take a piece and place on all of your lots with your bidder number then a dash then the corresponding lot number for each lot for example say my bidder number is 2504 so I would write on the green painter's tape with permanent black marker 2504-1

2504-3  
And so on
6. Now write the lot number for each of your lots in the lot# section starting with 1 and working your way down the sheet, there are 30 blank rows per sheet.
7. In the description row describe your lot that you're selling for example

lot #1 Fish tank no leaks 12x20x20

lot #2 Candles, picture frames, oil diffuser

lot #3 Kitchen utensils, pans, baking dish
